Centralized admissions to all State Quota seats (including Management/NRI seats) in all Government Medical / Dental Colleges, Govt. Society Medical Colleges, RUHS CMS, RUHS CDS, ESIC MC and Private Medical and Dental colleges in Rajasthan, for the session 2025-26, for all the four rounds of counselling i.e. Round 1, Round 2, Round 3 and Stray Vacancy Round, shall be made only by NEET UG Medical & Dental Admission/Counseling Board 2025. **All four rounds of allotments including stray vacancy round shall be conducted On-Line. No Round shall be conducted off-line. No admission shall be made at college level.** The Admission board shall conduct counselling for admission in the following courses:

1. Bachelor of Medicine; Bachelor of Surgery (MBBS) The duration of MBBS course is 4½ years followed by compulsory rotatory medical internship of one year:

The NEET UG 2025 counseling will be conducted for admissions to all State Quota seats (including Management/NRI seats) in all Government, Govt. Society Colleges, RUHS CMS, RUHS CDS, ESIC MC and Private Medical and Dental colleges in Rajasthan as per the rules and regulations laid down by National Medical Commission/Dental Council of India and directions from the Central Govt., State Govt. and Hon'ble Supreme Court and Hon'ble Rajasthan High Court.

The NEET score along with some relevant data has been provided by State Government(DME) to the Rajasthan State NEET UG Medical & Dental Admission / Counseling Board-2025.

All the allotments will be done by the Admission Board constituted by the State Govt. comprising of all Principals/Representatives of Principals of Medical/Dental Colleges of the State of Rajasthan.

Allotment of Course and College to the candidate shall be made according to the merit, the choice(s) filled by the candidate and availability of the seats as per the reservation policy of the state and in accordance with the rules and the directions laid down by Hon'ble Supreme Court of India/Hon'ble Rajasthan High Court/DCI/NMC/Government of Rajasthan, but the admission will be subject to verification of his/her documents/credentials for which the decision of the Principal of the concerned allotted college or the Board shall be final.

Only NEET UG 2025 qualified and candidates registered with Rajasthan State UG Admission/Counseling Board 2025 shall be eligible for admission.

1. ONLINE COUNSELLING

There shall be 4 (four) rounds of allotment process. All 4 rounds of allotment including Stray vacancy round shall be conducted on-line. No round shall be conducted off-line. No admission shall be made at college level.

2. APPLICATION FEE

All candidates are required to deposit non-refundable application fee of INR 2500/- (INR 1500/- for SC, ST, ST-STA category candidate of Rajasthan state domicile) + applicable transaction charges.

The application fee is neither refundable, nor transferable and nor adjustable for any future State UG admissions. Any plea in this matter shall not be entertained.

Please keep the information submitted in application form confidential and do not share with anybody. If you have filled application form but have not filled your choices during the notified period, you will not be considered for allotment but will be considered subsequently subject to fulfilling the applicable conditions.

All eligible candidates who wish to participate in the counseling process must register themselves through the above mentioned websites by completing Part 1 as well as Part 2 of application form.

A candidate who fails to register by completing both Part 1 as well as Part 2 of application form, shall not be eligible to participate in the further process of counseling.

3. VERIFICATION OF DOCUMENTS of PwBD/Defence Personnel/ Para Military/NRI Candidates

For verification of Certificate, candidate belonging to PwBD / Defence Personnel / Para Military Personnel/NRI **must present personally along with relevant original certificates/documents** and one set of photocopy of the same, at given place and time.

5. ELIGIBILITY CRITERIA

1. Educational Qualification

No candidate shall be allowed to be admitted to the MBBS or BDS course until he or she has passed the qualifying examination as under:

MBBS/BDS COURSE

Regarding eligibility for counselling/allotments in MBBS/BDS course for academic year 2025-26, MCC in its information booklet has mentioned as:

"Candidates must note that as per the NTA document, the following eligibility conditions must be met:

1. Provided also that to be eligible for NEET (UG) - 2025, the candidate must have passed in Physics, Chemistry, Biology/Biotechnology, and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry, and Biology/Bio-technology at the qualifying examination as mentioned in the Regulations of NMC and DCI. In addition, they must have got a rank in the merit list of NEET (UG) - 2025 for admission to Undergraduate Medical Courses.
2. In respect of the candidates belonging to Scheduled Castes, Scheduled Tribes, or Other Backward Classes (NCL), the minimum marks obtained in Physics, Chemistry, and Biology/Biotechnology are taken together in the qualifying examination shall be 40% marks instead of 50% marks for Unreserved and General-EWS Candidates. In respect of PwBD candidates as per NMC and DCI Regulations, the minimum marks in the qualifying examination in Physics, Chemistry, and Biology (or Botany & Zoology)/Biotechnology taken together shall be 40% instead of 50%."

In view of the Public Notice No. U -14021/12/UGMEB-2023 Dated 22.11.2023 issued by National Medical Commission, candidates who have undertaken study of the requisite subjects (Physics, Chemistry, Biology / Biotechnology along with English) even as additional subjects after passing Class 12th from duly recognized boards by the concerned Govt. shall be permitted to appear in counselling/admission process.

2. Age Limit

The candidate must have completed 17 years of age at the time of admission or will complete 17 years of age on or before 31 December of the year of his/her admission to the first year of the Undergraduate Medical/Dental Course.

Accordingly, the lower age limit shall be as under:

For Candidates of General (UR)/General-EWS: Born on or before 31.12.2008

For Candidates of SC/ST/OBC-NCL/PwBD Category: Born on or before 31.12.2008

Upper age limit: As per Letter No. U-11022/2/2022-UGMEB, dated 09 March 2022 of National Medical Commission (NMC), Under Graduate Medical Education Board (UGMEB) regarding the upper age limit, there is no upper age limit.

3. Other Eligibility Criteria

- I. Natural father/Mother of the candidate has continuously resided in Rajasthan for period of last 10 years and the candidate has studied for at least 5 years during this period in a recognized educational institution in Rajasthan, or
- II. All those students who are bonafide residents of Rajasthan but are studying in other states will also be eligible for the allotment process, or
- III. The candidate is son/daughter of serving or retired (i) Employee of Government of Rajasthan (ii) Officer of All Indian Services borne on State Cadres of Rajasthan and has served for more than 3 years with State Government, or
- IV. The candidate is son/daughter of serving or retired, permanent employee of Govt. Undertaking / Corporation / Improvement Trust / Municipal Bodies / Council / Panchayat Samiti / Co-operative bodies, duly constituted by the Government of Rajasthan by an act of Law who has put in at least 3 years of service on the last date of submission of the on-line application form in the year of admission, or
- V. The candidate is son/daughter of serving/retired, permanent employee of any of the State University or Secondary Board of Education (Rajasthan) provided that employee has worked in Rajasthan for 3 years preceding the last date of submission of the on-line application form, or
- VI. Candidate is a natural son/daughter of a Serving/Retired permanent employee of Indian Defense and the employee is of Rajasthan origin irrespective of his place of posting. Provided that in case of Defense Personnel from Rajasthan origin, a certificate (**certificate proforma – A**) has to be submitted by them from the employer to the effect that his state of origin is Rajasthan at the time of his entry into service. Eligible candidates of this category shall be admitted as per laid down criteria of priority cum merit of the Rajasthan MBBS & BDS Admissions 2025, or
- VII. Candidate is a natural son/daughter of a Serving permanent employee of Indian Defense and the employee is posted in Rajasthan (**certificate proforma – B**) at the time of last date of submission of the on-line application form for admission, or
- VIII. Candidate is a son/daughter of serving/Retired person of Para-Military Forces of India and the employee is of Rajasthan origin, irrespective of his place of posting. Provided that in case of Para-Military personal from the Rajasthan origin, a certificate (**certificate proforma – A**) has to be submitted by them from the employer to the effect that his state of origin is Rajasthan at the time of his entry into service, or
- IX. Candidate is a son/daughter of serving person of Para-Military Forces of India and the employee is posted in Rajasthan (**certificate proforma – B**) at the time of last date of submission of the on-line application form for admission, or
- X. Candidate is a son/daughter of a Judge of Rajasthan High Court subject to the condition that he/she submits an undertaking/affidavit stating that such benefit is not being claimed or availed by them in any other State, or

(candidates falling in above clauses I to X are eligible for all types of seats, i.e. Govt./Management/NRI)

XI. Other **(for candidates who are not covered under the above clauses from I to X)**

(candidates selecting clause XI "Other" are eligible to apply to participate but will be considered for allotment against vacant seats (Govt./Management/NRI) available after exhausting State Merit list during / after round 3).

(candidates selecting clause XI "Other" and having NRI eligibility will be considered for allotment against NRI seats in all rounds according to the applicable norms).

Please see the individual institution's website regarding fees and other formalities.

4. Eligibility for NRI Candidates

As per order no. F.5(968)DME/LC/2018/1997 dated 29.04.2019 of Government of Rajasthan **(Annexure-2)**, following will be the guidelines applicable for the admission in Under Graduate/Post Graduate, Medical/Dental courses under NRI quota in all Government, Govt. Society institutions and RUHS CMS of the State:

- 1) At least one of the parents of students should be an NRI and shall ordinarily be residing abroad as an NRI; or
- 2) The person who sponsors the student for admission should be a first degree relative of the student (i.e. real Brother / real Sister) and should be ordinarily residing abroad as an NRI; or
- 3) If student is taken as a ward by some other nearest relative [as mentioned below (i) to (v)] such students also may be considered for admission provided the guardian has bonafidely treated the student as a ward. For this following nearest relative (NRI) of candidate, who should be ordinarily residing abroad as an NRI can only be considered:
 - i. Real brother and sister of father i.e. real uncle and real aunt.
 - ii. Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
 - iii. Father and mother of father i.e. grandfather and grandmother.
 - iv. Father and mother of mother i.e. maternal grandfather and maternal grandmother.
 - v. First degree-paternal and maternal cousins.
- 4) All NRI Candidate shall submit a proof being sponsor as NRI/OCI/PIO in the form of certificate issued by the Indian embassy/Ministry of external affairs, Government of India for this purpose. In the absence of that certificate a duly notarized undertaking executed by the sponsor and notarized by the Notary Public of the foreign country where the sponsor resides being submitted by the sponsor, it be treated as sufficient as to the factum of the residence of the sponsor.

5) An affidavit from the sponsor that he/she looks after such student and will sponsor the entire course fee of the candidate.

6) According to the direction of the State Govt.:

- (i) Round 3 counselling for NRI seats remaining vacant after round 2 shall be conducted separately before starting the round 3 allotment process for Non-NRI seat.
- (ii) The NRI seats remaining vacant on allotment of round 3 shall be converted to the seats from where the NRI Seats derived and would be filled during the round 3 allotment process of Non-NRI seats.

The candidate who gets allotment to NRI seats in round 3 counseling shall not be eligible to participate in round 3 counseling for other seats and shall at the time of joining submit a bond that if leaves the course before completion, shall be liable to pay the fee for entire course prescribed for such NRI seat.

5. Reservation

As per order no. F.5(968)DME/LC/2018/1997 dated 29.04.2019 of Government of Rajasthan

- a) 15% of the seats in Govt. Medical Colleges and Govt. Society Medical Colleges (RajMES) / RUHS Medical College / ESIC MC / RUHS CDS will be reserved in MBBS/BDS Course to be filled up on all India basis conducted by DGHS.
- b) 24 seats, 4 in each State Medical College (6 Govt. colleges) of Rajasthan of MBBS Course will be reserved for candidates selected under the Central Government pool. The Central Government Authority will fill up these seats.

Note: The remaining seats (including 50% seats of ESIC MC) shall be treated as the State Seats and will be filled up on merit cum-preference in Rajasthan MBBS & BDS Admissions 2025 with following reservations: -

- c) (i) 16% seats, after excluding the seats of sub- clause (a), (b) above are reserved for natural born (not adopted) candidate belonging to Scheduled Caste as notified in the Presidential Order for the State of Rajasthan and who fulfill other relevant conditions;

(ii) 12% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for natural born (not adopted) candidates belonging to Scheduled Tribe as notified in the Presidential Order for the State of Rajasthan and who fulfill other relevant conditions;

45% of ST seats are to be for ST candidates who are bonafide residents of scheduled area (tribal area);

(iii) 21% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for those belonging to Other Backward Classes NCL (OBC NCL) of the State of Rajasthan and who fulfill other relevant conditions. **Candidate must submit valid OBC Certificate for Rajasthan State issued by competent authority of Rajasthan (clearly indicating 'Non Creamy Layer')**. Refer the direction letter no. 54159, dated 09.09.2015 issued by Social Justice and Empowerment Department, Govt. of Rajasthan, Jaipur.

(iv) 5% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for those belonging to More Backward Classes NCL (MBC NCL) of the State of Rajasthan and who fulfill other relevant conditions. **Candidate must submit valid MBC Certificate for Rajasthan State issued by competent authority of Rajasthan (clearly indicating 'Non Creamy Layer')**. Refer the direction letter no. 54159, dated 09.09.2015 issued by Social Justice and Empowerment Department, Govt. of Rajasthan, Jaipur.

(v) 10% seats, after excluding the seats of sub-clauses (a), (b) above are reserved for those belonging to Economically Weaker Sections (EWS) of the State of Rajasthan and who fulfill other relevant conditions. **Candidate must submit valid EWS Certificate for Rajasthan State issued by competent authority of Rajasthan (valid for financial year 2025-26)**. Refer the direction letter no. 28046, dated 06.05.2022 issued by Social Justice and Empowerment Department, Govt. of Rajasthan, Jaipur.

- d) Not less than 25%, out of each category of SC, ST, STA, OBC-NCL, MBC-NCL, EWS and unreserved category shall be filled from female candidates.
- e) 1% seats (in Government medical colleges/ Govt. Society Medical Colleges (RajMES)/ RUHS CMS / ESIC MC / RUHS CDS) after excluding the seats of sub clauses (a), (b) are reserved horizontally on priority cum merit for the natural born (not adopted) sons/daughters of Defence Personnel (serving / retired) of Rajasthan Origin, and para military personnel (serving / retired) of Rajasthan origin (in ratio 3:1). 50% out of these reserved seats shall be reserved for girls, unfilled seats will be reverted to boys category.

As per the Kendriya Sainik Kalyan Board, the defence seat is admissible for only one member of the family, once in lifetime. Only wards of Defence Personnel from Army, Air Force & Navy from serial 1 to 9 below are eligible for the scheme. Candidate should bring an undertaking on Rs. 50 Non-Judicial Stamp paper for compliance of letter no. F25/SKV/2022/13423-30 Dated 13.10.2022 of Sainik Kalyan Vibhag, Govt. of Rajasthan.

As per letter no. 6(1)/2017/D (Res.II), dated 19.05.2017 and it's subsequent amendments in Nov. 2017 and 21.05.2018 issued by Dept. of Ex- serviceman welfare, of Govt. of India and SOP letter no. 370/Adm/MBBS/BDS/c, dated 01.07.2020 of Kendriya Sainik Kalyan Board, Ministry of Defense, Govt. of India, priority order (**certificate proforma 1**) for Defence personnel of Rajasthan origin, will be as follows:

1. Widows/Wards of Defence Personnel killed in action.
2. Wards of those Disabled in action and boarded out from service
3. Widows/Wards of those Defence personnel who died while in service with death attributable to military service
4. Wards of those Disabled in service and boarded out with disability attributable to military service.
5. Wards of ex-service men and serving personnel who are in receipt of Gallantry Award.
6. Wards of ex-service men.
7. Wives of (i) defence personnel killed in action and boarded out from service
(ii) defence personnel disabled in service and boarded out with disability attributable to military services (iii) ex-servicemen and serving personnel who are in receipt of Gallantry Award
8. Wards of serving personnel
9. Wives of serving personnel

As per the letter no. F25/SKV/2022/13423-30 Dated 13.10.2022 of Sainik Kalyan Vibhag, Govt. of Rajasthan, the para-military seat is admissible for only one member of the family once in life time. According to the MHA (Ministry of Home Affairs), only wards of Para-military personnel from serial 1 to 3 below are eligible for the scheme. Candidate should bring an undertaking on Rs. 50 Non-Judicial Stamp paper for compliance of letter no. F25/SKV/2022/13423-30 Dated 13.10.2022 of Sainik Kalyan Vibhag, Govt. of Rajasthan.

Priority order (**certificate proforma 2**) for Para-military personnel of Rajasthan origin, will be as follows:

1. Wards/ Widows /Wives of those Paramilitary personnel killed in action.
 2. Wards/ Widows /Wives of those Paramilitary personnel permanently disabled in action and boarded out from service.
 3. Wards of All serving and retired personnel.
- f) 5% seats out of each category of 16% (SC), 12% (ST), 21% (OBC), 5% (MBC), 10% EWS and the remaining shall be further reserved on Merit-cum-Priority in each category horizontally for candidates with benchmarked disabilities (PwBD) under the Rights of Persons with Disabilities Act, 2016 and in accordance with Interim Guidelines no. NMC/UGMEB/PwBD/2025, dated 19.07.2025 issued by National Medical Commission (**Annexure 1**).

The "Certificate of Disability" issued by 16 centers approved by MCC in accordance with the Rights of Persons with Disabilities Rules, 2017 and as per norms of Regulating Authority shall only be considered. List of approved centers is attached as **Annexure 1A**.

Certificate issued by any other Government Medical College/District Hospital/Government Hospital will NOT be accepted.

Note: The PwBD candidates must ensure that they possess the disability certificate issued for NEET UG admissions 2025, by amongst 16 centers approved by MCC.

Refer order no. Ref. U-11011/07/2025-MEC Dated: 21.07.2025.

The candidate must bring the certificate issued to them, on the notified date for verification.

- g) No reservation will apply on NRI seats of all Medical/Dental Colleges.

For admission under NRI Quota in Medical/ Dental courses in the colleges in the State of Rajasthan, priority shall be given to the NRI with ancestral background of the State of Rajasthan by own/parents/Grandparents resided in State of Rajasthan at least for a period of 5 years at any time. The proof of residence will also be applicable for the consideration priority for NRI Quota, for which document (Electricity/ Water bill/ Documents of immovable property/ Indian Passport/ Ration Card/ Voter ID/ Aadhaar Card etc.) to the effect for this criteria is required to be submitted by ward of NRI (including PIO/ OCI).

Firstly, NRI Quota seats shall be allotted to candidate having ancestral background of the State of Rajasthan by own/parents/Grandparents resided in State of Rajasthan at least for a period of 5 years. Later on remaining Vacant NRI seats will be allotted/ filled by the candidates of NRI belonging to other states.

For PIO / OCI: Overseas Citizens of India (OCI), Persons of Indian Origin (PIO) are allowed for admission under NRI Quota.

(For detailed guidelines, read this Information Booklet carefully).

- h) During/after the third round of counseling the unfilled reserved seat(s) of any category from sub-clauses (c) to (f) shall be treated un-reserved and shall be filled accordingly.

6. SEAT MATRIX

The seat matrix for choice filling will be available on website in due course.

As per regulatory body, there are 3 types of seats, namely - Government seat, Management seat and NRI seat.

Responsibility of type of seats in the seat matrix shall lie with the concerned institution and not with the Counseling Board. It is on the part of the concerned medical / dental college to provide the categories of seats as well as fee to be charged for that category in accordance to the laws, rules and guidelines applicable to them.

7. FEE DETAILS

Fee details as provided by the concerned institute will be published in due course. Responsibility of type of seats and Fee levied on such seats shall lie with the concerned institution and not with the State Counseling Board.

Refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.

8. APPLICATION PROCEDURE

Before filling the on-line application form, read the information booklet and instructions for filling on-line application form etc. very carefully.

You should be very careful in filling-up the on-line application form. If any lapse is detected during the scrutiny, your candidature will be rejected even if you come through the final stage of admission process or even at a later stage.

Candidate should be very careful in filling-up the on-line application form and must ensure fulfillment of the eligibility criteria etc. at the level of concerned College/University. If at any stage he/she is found non-eligible for admission to the allotted course, his/her candidature is subject to rejection even if he/she comes through the final stage of admission process or even at a later stage.

IMPORTANT: HAND WRITTEN / TYPED / PHOTOSTAT COPIES / PRINTED APPLICATION FORM / SCREEN PRINTOUT WILL NOT BE ENTERTAINED.

Follow the steps as given in "Instructions to fill up on-line application form" available at the website.

Note the ID and password for further steps. Keep it safe and confidential.

CONDITIONS APPLIED ON APPLICATION FORM AND THE DOCUMENTS REQUIRED AT THE TIME OF JOINING

4. Date of Birth Certificate: 10th class mark sheet / certificate or any other equivalent certificate showing the date of birth
5. Mark sheet of secondary examination (10th class)
6. Mark sheets of Class 11 bearing Biology as one of the subjects (if passed in more than one attempt, all mark sheets are required)

Note: In case a candidate has passed Class 11th with Biology during COVID time, then he should submit a certificate issued by Principal of the School clearly mentioning all subjects which he has studied in Class 11th.

7. **Certificate/ Document providing your eligibility as selected by you at the time of filling on-line application form- (I to XI) - as given under serial 3 under other eligibility criteria in the information booklet**

Additional documents for candidates applying for NRI seats

16. If the Sponsor NRI/OCI/PIO is currently residing in India, a proof in the form of certificate issued by the Indian embassy in the concerned Country/Ministry of external affairs, Government of India for this purpose is essential along with undertaking in the prescribed **Proforma-3** on non-judicial stamp paper of Rs. 50/- executed by Sponsor NRI/OCI/PIO and duly notarized.

or

If the Sponsor NRI/OCI/PIO is residing outside India, a duly notarized undertaking in the prescribed **Proforma-4** executed by the sponsor and notarized by the Notary Public of the foreign country where the sponsor resides being submitted by the sponsor, it be treated as sufficient as to the factum of the residence of the sponsor. **NRI undertaking must have been issued on or after date of NEET 2025 examination i.e. 04.05.2025.**

17. Father/Mother/Guardian shall also submit an undertaking regarding relationship between Sponsor and candidate in **Proforma-5** along with the address of parents and local (Indian) guardian.
18. Address proof of parents and local (Indian) guardian

Candidates will be required to submit the print copy of the application form (duly completed in all respects) at the time of reporting at the specified place OR allotted medical / dental college (as per direction given by the Admission Board), failing which their candidature shall be rejected / they will be disqualified without any further correspondence.

ELIGIBILITY DECLARATION BY CANDIDATES

Before filling application form candidate must ensure that he/she also has obtained minimum qualifying marks in each subject and passed in theory as well as practical examination individually (Physics, Chemistry and Biology/Biotechnology) and English, and also have qualifying percentile in NEET UG 2025.

Candidate should ensure his/her eligibility etc. and that the declaration made by the candidate in the format of application regarding his/her eligibility is correct in all respects. Candidate will be liable for any legal action and / or punishment as may be deemed fit by the Admission Board in case it is found that he/she has furnished incorrect information or made false declaration regarding the eligibility at any stage or suppressed any information.

9. CHOICE FILLING

The guidelines and requirements for choice filling will be available with publication of seat matrix. Candidates must fill their choices, very carefully, based on the seat matrix and corresponding fee structure.

If a candidate does not submit his/her choice till the specified date and time, he/she will lose chance of participation in the on-line allotment process. The choices are required to be filled very carefully as the choices filled shall be final for on-line allotments for that round only.

It is mandatory to fill fresh choices in each and every round irrespective of whether the candidate was allotted/joined a seat in previous round or not (subject to the candidate is eligible to participate and willing to participate/upgrade in subsequent round). The choices filled by a candidate in previous round shall be scraped off and will not be considered for further rounds.

Note: If a candidate does not fill fresh choices for a round then he/she will not be considered for allotment / upgradation in that round.

Candidates participating in round 2 or round 3 of the counselling may fill the choices also for the virtual vacancies that may arise due to upgradation by a joined candidate of earlier round.

Candidate participating in the counselling process shall be considered on the vacancies available at his/her merit. Any virtual vacancy that may arise after passing over of the merit of a candidate shall not be available to that candidate.

It is clarified that any virtual vacancy that may arise due to upgradation by a joined candidate shall be available only to the candidates on next merit.

If a round 1 allotted and joined candidate does not fill choices for round 2, then he/she will not be considered for upgradation in round 2 (as per his/her merit) and the seat allotted to him/her in round 1 will be considered retained as such.

If a round 1 / round 2 allotted and joined candidate does not fill choices for round 3, then he/she will not be considered for upgradation in round 3 (as per his/her merit) and the seat allotted to him/her in round 1 / round 2 will be considered retained as such.

10. ALLOTMENT OF SEATS

The allotment of seats shall be conducted strictly in accordance with the merit list prepared on the basis of All India Merit in NEET 2025 (of NEET 2025 qualified and State registered candidates), the order of choices / options filled in by the candidates in the application form **(Candidates are advised to fill the choices very carefully after referring the Fees displayed at the time of choice filling and also College Information Sheet of the respective college).**

All rounds of State NEET UG (Medical/Dental) Counseling 2025 shall be held on-line.

SELECTION OF STUDENTS

- The selection of students to a Medical / Dental College shall be based solely on the All India merit of the candidate through NEET UG 2025.
- To be eligible for MBBS & BDS Admissions 2025, the candidate must have fulfilled the eligibility criteria as mentioned in this booklet.
- The eligible qualified candidates in the NEET UG 2025 will be admitted in the order of merit for the general as well as reserved seats excepting the seats belonging to the category of the sub-clause 'e' of clause-5 (regarding defence/paramilitary wards) in which case it would be priority-cum-merit.

The allotment of seat to a candidate shall remain provisional till verification of original documents/credentials, eligibility and fulfilment of medical fitness criteria, at the allotted college.

A candidates will be deemed to have joined an institution once his/her original documents are submitted, reported physically at the desk of allotted institution at Academic block, SMS Medical College, Jaipur, at the time of reporting and have deposited the requisite one-year tuition fee.

11. CONDITIONS RELATING TO BOND / FEE STRUCTURE

Conditions relating to bond etc. (applicable for Government colleges/Govt. Society Colleges/RUHS CMS)

The candidates selected on Govt. seats (Except Management and NRI Seats) in above medical colleges will have to submit a bond of commitment not to leave the course before completion and to serve the State Government for 2 years after completion of the course, amounting to Rs. 10.0 lakhs (Rupees Ten lakhs).

In consonance with Govt. of Rajasthan letter no. F.7(86) CM-HM-Budget-DME-Acad.-2015-3285 dated 15.07.2021, a candidate joining on management seat in Govt. Society Colleges/RUHS CMS shall be required to submit a bond to the effect that in case he/she leaves the MBBS course before its completion, fees of all remaining semesters of the course shall be payable by him/her.

The candidates selected against NRI seat in above medical colleges will have to submit a bond for fees of the remaining period for depositing on a regular basis. In case he/she leaves the MBBS course before its completion, fees of all remaining semesters of the course shall be payable by him/her.

The candidates selected in RUHS College of Dental Sciences (Govt. Dental College) will have to submit a bond of Rs. 4.0 lakhs (Rupees four lakhs) in favour of Principal of the said college along with Bank Guarantee of Rs. 1.00 lakh. If the candidate leaves the course before its completion, the Bank Guarantee and Bond will be forfeited by the college.

Refer the annexure for **Proforma of the Bond (Proforma – 6)**.

Conditions relating to bond / bank guarantee etc. (applicable for private colleges)

At the time of joining (on completion of round 3), all the joined candidates of round 1, round 2 as well as round 3 will have to submit a bond / bank guarantee* (if applicable). For details, refer website of respective private colleges / contact college office.

* Refer the judgment dated 31.05.2021 of Hon'ble Rajasthan High Court at Jodhpur in DBCWP No. 13535/2020. The matter is sub-judice before the Hon'ble Supreme Court in SLP (C) No. 11296/2021.

12. SECURITY AMOUNT (for MBBS/BDS course)

Before choice filling stage, candidates participating for Medical/Dental seats will have to pay refundable security amount as under:

Rs. 50,000/- for UR/EWS, SC/ST/ST-STA/OBC/MBC candidates opting for Govt. Seat (MBBS course) in Government Medical Colleges, Govt. Society Medical Colleges, RUHS CMS, ESIC MC

Rs. 2,00,000/- for candidate opting for Management Seat (MBBS Course) in Govt. Society Colleges.

Rs. 5,00,000/- for candidate opting for NRI Seat (MBBS Course) in Govt. Society Colleges.

Rs. 5,00,000/- for candidates opting for MBBS Course in Private Medical Colleges

Rs. 10,000/- for candidates opting for BDS Course Govt. Dental College (RUHS CDS) or Private Dental Colleges

[Candidates depositing Rs. 2,00,000/- or 5,00,000/- will automatically be eligible to fill choices for Government Medical / Dental Colleges, Govt. Society Medical Colleges, RUHS CMS, RUHS CDS, ESIC MC and Private Dental College].

The Security Deposit will be forfeited if a candidate who has been allotted a seat in the Round 2 or subsequent rounds and does not join the respective institution.

Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason e.g in case the candidate gives wrong information at the time of registration (application form filling) on the basis of which a seat may be allotted and later cancelled by the Board or fails to produce the required essential documents at the time of joining (within stipulated time).

1. If a candidate joins his allotted seat in any round of counselling, his/her security amount will be adjusted in the tuition fee to be deposited for the allotted college.
2. The security amount if not forfeited or adjusted in fee, will be refunded after completion of counseling process, to the concerned bank account from which the security amount is deposited.
3. A candidate allotted a seat in Round 1 and does not join the allotted college will be eligible for subsequent round without forfeiture of security amount.
4. Round 1 joined candidate who has not been up-graded during round 2 counseling or has not participated in round 2 may resign without forfeiture of security amount within two days of declaration of round 2 result, failing which he will be considered as joined candidate for round 2 and rules will apply accordingly.
5. A candidate allotted a seat (fresh / upgraded) in round 2 of counseling and does not join the allotted seat, his/her security amount will be forfeited. Such candidate shall be eligible to participate in further rounds of counseling on fresh application (Re-registration) and on depositing security amount again.
6. Any candidate who retains his round 1 allotted seat (after two days of declaration of result of 2nd round of counselling) and candidates who join their round 2 allotted seat will not be allowed to resign (including returning of original documents) on or before the last date of admissions as scheduled by MCC/NMC/DCI and the conditions of bond shall be applicable.
7. A candidate having joined status on completion of round 2 and willing to participate for upgradation in round 3 will be eligible for participation in Round 3 of the counselling.
8. A candidate allotted a seat (fresh / upgraded) in round 3 of counseling and does not join the allotted seat, his/her security amount will be forfeited. Such candidate shall not be eligible to participate in stray vacancy round.
9. Candidates having joined status after round 3 will not be allowed to participate in Stray vacancy round.
10. A candidate allotted a seat in stray vacancy round does not join the allotted seat **shall be debarred from participating in the State counseling process for next one year**, along with forfeiture of security amount and bond conditions shall be applicable.
11. Candidate who joins the course on allotment of round-3 counselling or retains his or her seat (allotted in earlier round) in round-3 or a candidate who joins the course on allotment in stray vacancy round, shall not be allowed to resign the course (including returning of original documents) on or before the last date of admissions as scheduled by MCC/NMC/DCI and conditions of bond shall be applicable.

Note: No candidate can join two colleges/institutes at the same time. At the time of round 2 or 3 of the allotment process, such candidates who have registered for the state counseling and who have joined other college/institute (as on a specified date) through round 2 or 3 of All India counseling or any other counseling and hence as per the directions of Hon'ble Supreme Court shall be in-eligible for allotment in State round 2 or 3 and stray vacancy round.

Stray Vacancy Round: For participation in stray vacancy round, it is mandatory for eligible candidates to get their documents verified and submit all relevant original documents along with a Bond in prescribed format, with the Board. Candidate whose documents are not verified or who does not submit his /her original documents along with bond, will not be allowed to participate in stray vacancy round. Documents of such candidates will be kept by the counselling board after verification. Documents of candidates who do not get any allotment will be returned by the dates notified.

13. JOINING AT THE COLLEGE AFTER COUNSELLING

All candidates allotted a seat through State NEET UG Counselling for MBBS/BDS Course will have to report in-person at Academic Block, SMS Medical College, Jaipur (at the desk of the allotted college) by the notified date and time.

Round 1

The candidates admitted to all medical / dental colleges will have to deposit one year tuition fees of the allotted college (the Security amount will be adjusted in Tuition Fee) only through electronic (on-line) mode in the **bank account*** of Chairman NEET UG Counselling Board 2025, which will be handed over to the allotted college (refer the website for fee details of all participating colleges). Receipt of such electronic transaction duly verified by the bank and original documents, requisite bond will have to be submitted at the time of joining at the desk of the concerned allotted college.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

Round 2

The candidates admitted to all medical / dental colleges will have to deposit one year tuition fees of the allotted college (the Security amount will be adjusted in Tuition Fee) only through electronic (on-line) mode in the **bank account*** of Chairman NEET UG Counselling Board 2025, which will be handed over to the allotted college (refer the website for fee details of all participating colleges). Receipt of such electronic transaction duly verified by the bank and original documents, requisite bond will have to be submitted at the time of joining at the desk of the concerned allotted college.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

Round 1 allotted and joined candidates will be considered for upgradation in round 2. For this upgradation, a round 1 allotted and joined candidate is mandatorily required to fill choices for round 2. In case he/she is allotted a different seat in round 2, his/her seat allotted (and joined) in the round 1 will automatically be vacated (and will be available for allotment to other candidates) and such a candidate will be required to join at the seat allotted during round 2).

Note: Original documents and Fee deposited in round-1 of the upgraded candidates shall be transferred directly to the upgraded college and will not be handed over to the candidate.

Round 3

The candidates admitted to all medical / dental colleges will have to deposit one year tuition fees of the allotted college (the Security amount will be adjusted in Tuition Fee) only through electronic (on-line) mode in the **bank account*** of Chairman NEET UG Counselling Board 2025, which will be handed over to the allotted college (refer the website for fee details of all participating colleges). Receipt of such electronic transaction duly verified by the bank and original documents, requisite bond will have to be submitted at the time of joining at the desk of the concerned allotted college.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

Candidates having joined status in round 2 will be considered for upgradation in round 3. For this upgradation, a candidate is mandatorily required to fill choices for round 3. In case he/she is allotted a different seat in round 3, his/her seat allotted (and joined) in the earlier round will automatically be vacated (and will be available for allotment to other candidates) and such a candidate will be required to join at the seat allotted during round 3.

The candidates who retain round 1 / round 2 allotted seat in round 3 of counseling will have to submit fees and complete other formalities as per guidelines given in the respective college website by the last date of joining of third counseling.

Note: Original documents and Fee deposited in earlier round of the upgraded candidates shall be transferred directly to the upgraded college and will not be handed over to the candidate.

Stray Vacancy Round

The candidates who get allotment will have to deposit one year tuition fees in the **bank account*** of Chairman of NEET PG Counseling/admission Board only through electronic (on-line) mode. Candidate will then have to deposit the proof of on-line deposition of fee along with all original documents and requisite bond to the representative of allotted college (please refer to respective college website). The bank account details of counselling board for online fee deposition will be made available on the allotment letter of the individual.

* This Bank account will be mentioned in allotment letter issued to the candidates and will be specific/unique to the concerned candidate only and will be meant for use ONLY by the concerned candidate while depositing the tuition fee. It is to be noted that this bank account no. will be different for each allotted candidate, so a candidate must not share this bank account no. with any other allotted candidate and also must not use bank account no. of other allotted candidate while depositing his/her tuition fee.

The candidates will also have to submit other fees / charges and complete other formalities as per guidelines given in the respective college website at the allotted college, by the date and time notified.

Important (for all rounds)

Each candidate shall join the allotted college and course within the time as mentioned in the allotment letter issued on-line. There is no provision for accepting any request of extension for joining date under any circumstances. The allotment made will be **firm and final**. Change of college/course from one place to another is not permitted. Therefore, request for the same would not be entertained by the Admission Board after the allotment.

The selected candidates should bring all the requisite documents in original and also submit an undertaking in **Proforma-7** that the **submitted documents are in original** along with one set of self-attested copies of documents, at the time of joining at the allotted college, failing which their admission shall stand cancelled. These original documents may be kept with the institution till completion of the course.

The selected candidates will be required to undergo medical examination at the allotted institution on the notified date(s).

If any candidate is not able to report for Medical Examination at the Institution on the notified date on medical grounds or due to some other circumstances beyond his/her control and his/her parent/guardian comes in person on his/her behalf for verification of the original certificates to the college he/she will be considered for provisional admission. His / Her formal admission will be confirmed only when he/she is found medically fit and fulfills other requirements as per the dates notified.

Candidates who fail to attend medical examination or found **medically unfit will be disqualified for admission.**

The academic session will commence from 01.09.2025.

If a candidate is pursuing study or admitted in an Institution (other than the institution allotted through this Board) and gets allotment through this Board then he/she must present the **accepted resignation/relieving letter** from the institution he/ she is pursuing studies at present, at the time of joining at the desk of the allotted college. Failure to do so will result in disqualification for admission.

A candidate **without Original certificates / documents** shall not be allowed to take admission at the allotted college under any circumstances. A candidate who has already been admitted in MBBS/BDS course and has deposited his / her certificates in any medical/dental college/ institute / university and participates in counseling (allotment process) and at the time of reporting appears with a certificate stating that **"his/her original certificates are deposited with the medical/dental college/ institute / university"** (except the college allotted through NEET-UG counseling 2025 of Rajasthan state process), will **NOT** be allowed to take admission at the allotted college.

The colleges shall be provided the list of candidates allotted. The colleges shall verify the credentials of reporting candidates as per this list and check the documents and other required certificates with originals.

The admissions shall be treated as provisional subject to the final decision of any pending case(s) in any court of law, if applicable to these admissions. Further, the provisional status of admission shall stand cleared only after enrolment by the concerned University.

The non-viewing of the websites about allotment information by the candidate shall not be accepted as a ground for non-joining by the scheduled time and date. The candidate's allotment will stand automatically cancelled if he/she does not join IN PERSON at the allotted college as per the notified schedule.

IMPERSONATION

If at any stage, it is found that any candidate has indulged in any case of impersonation i.e. not matching the biometric/ photograph/ signature/ videography/ documents of the candidate etc. he/she will be handed over to the Police and the cases will be dealt as per the Indian Penal Code. **Such candidates will be debarred permanently from taking MBBS/BDS Admissions in Future.**

The jurisdiction for legal cases arising out of Rajasthan MBBS & BDS Admissions 2025 shall be High Court of Rajasthan.

The decision of the Admission Board in all aspects and all respects pertaining to the application and its acceptance or rejection as the case may be, conducting of counseling and at all consequent stages culminating in the admission or otherwise of any candidate shall be final in all respects and binding on all concerned.

The admission board reserves its right to alter and modify time and conditions laid down in the notification, information booklet for conducting the various stages up to the admission, duly intimating details thereof on the website, as warranted by any unforeseen circumstances arising during the course of this process, or as deemed necessary by the admission board at any stage.

14. ABBREVIATIONS

16. DISCLAIMER

The apex court drew guidelines for the management of all educational institutions to follow. Among them:

Educational institutions should take anti-ragging measures right from the time of advertisement for admissions. The prospectus, the form for admission and/or any other literature issued to aspirants for admission must clearly mention that ragging is banned in the institution and anyone indulging in it is likely to be punished appropriately which may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology.

The punishment may also take the shape of: (i) withholding scholarships or other benefits (ii) debarring from representation in events (iii) withholding results (iv) suspension or expulsion from hostel or mess. If there be any legislation governing ragging or any provisions in statute/ordinance, it should be brought to the notice of the students/parents seeking admissions. A printed leaflet detailing when and to whom a victim may turn for information, help and guidance for various purposes, keeping in view the needs of new entrants, along with their addresses and telephone numbers should be given to fresher at the time of admissions so that they need not to look to seniors for help in such matters.

In alignment with the Hon'ble Supreme Court's judgment in *OmRathod vs. Union of India* and related rulings, the National Medical Commission established an expert committee to reassess AppendixH-1 of the 2019 Disability Guidelines (originally issued by the Medical Council of India on 13 May 2019). The objective is to ensure that the Appendix aligns with the Rights of Persons with Disabilities Act, 2016, and the Notification of Ministry of Social Justice and Empowerment dated 12March2024 concerning updated disability assessment standards.

2. After thorough consultations, the Interim Guidelines outlining the assessment method for admitting PwBD candidates to the MBBS course have been framed and are made implementable for the admissions in academic year 2025-26.

3. As per the Interim Guidelines, the following is the procedure for admission in MBBS Course in Academic Year 2025-26:

- PwBD candidates must submit:
 - A **valid UDID card** issued by a designated medical authority under Ministry of Social Justice (MoSJE).
 - **Self-Certified Affidavits** in the format provided under **Schedule -I**.
 - The candidate will have to report to the designated medical board (16 designated medical boards) for verification of their self-certified affidavit.

4. The Designated Medical Boards are responsible for

verifying candidate's self-certified affidavits and evaluating their functional abilities. Detailed assessment procedures for these boards are set forth in the Interim Guidelines.

5. In view of the above, the candidates applying under PwBD category are advised to visit Intra MCC portal for detailed instructions.

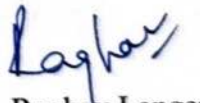

INTERIM GUIDELINES ON ASSESSMENT METHOD FOR GRANTING ADMISSION IN MBBS COURSE TO PwBD CANDIDATES FOR AY 2025-26

PREAMBLE:

In pursuit of equitable and inclusive medical education, the National Medical Commission (NMC) remains steadfast in its commitment to ensuring fair access to medical courses for all eligible candidates, including Persons with Disabilities (PwD). In alignment with the provisions of the Rights of Persons with Disabilities Act, 2016, and the Graduate Medical Education Regulations, this interim report outlines the foundational framework and preparatory measures for facilitating the admission of PwBD candidates in MBBS Course.

This report serves as a step towards strengthening existing mechanisms, identifying challenges, and proposing recommendations for creating an enabling environment that upholds the principles of dignity, non-discrimination, and equal opportunity. It focuses on key aspects such as assessment of disability, eligibility criteria, reasonable accommodations, accessibility standards, and institutional readiness.

The NMC acknowledges the valuable contribution of a diverse medical workforce and envisions a system where every aspiring student, irrespective of physical or cognitive ability, is empowered to pursue a career in medicine and serve society with competence and compassion.

1. Introduction

In alignment with the **Rights of Persons with Disabilities (RPwD) Act, 2016**, and subsequent notifications, particularly the directive issued by the **Ministry of Social Justice and Empowerment (MoSJE)** on **12.03.2024**, which underscores the principles of inclusive education and reasonable accommodation, and the landmark judgment of the **Hon'ble Supreme Court dated 25.10.2024** in *Om Rathod vs Union of India & Others* (SLP (C) No. 21942 of 2024), a significant shift has been initiated in the national approach toward disability inclusion in higher education.

2. Functional Competency Approach

These legal and policy developments collectively emphasize the prioritization of **functional competency** over rigid **percentage-based disability thresholds**. In response, the **National Medical Commission (NMC)** has undertaken proactive measures to ease challenges faced by PwBD candidates, ensuring a fair and inclusive medical education environment. This includes facilitating reasonable accommodations, revisiting eligibility norms, and adopting evaluation criteria focused on individual capabilities.

3. Deliberations and Guideline Development

Extensive deliberations were held in various meetings of the NMC, engaging a committee of medical experts. A consensus emerged to develop a **comprehensive guideline** focused on functional ability and reasonable accommodation to enable the fair inclusion of PwBD candidates in the **MBBS program**, without subjecting them to undue hardship or exclusion.

This initiative is aimed at reinforcing existing systems, identifying practical challenges, and formulating evidence-based recommendations to build an enabling environment grounded in the principles of dignity, non-discrimination, and equal opportunity. It will focus on critical areas including disability assessment, eligibility criteria, and provision of reasonable accommodations, accessibility standards, and institutional preparedness

4. Interim Admission Approach for AY 2025-26

Defining essential competencies for each type of disability involves a very complex process which is multi-dimensional & dynamic. Assistive devices & medical technologies are also rapidly advancing & evolving. Striking a balance between inclusion and the imperatives of patient safety and clinical competence in medical education and practice is of paramount importance.

Pertinent to mention that Post Graduate medical courses shall require specialty specific deliberations, as the required competencies and skills may vary over a wider range and therefore additional consultations with medical experts/ beneficiaries/ stakeholders are needed.

In view of aforesaid facts, final guidelines after following all procedural aspects and further consultations, shall be notified & implemented from subsequent Academic Years. However, the admission process for **PwBD** candidates for **AY 2025-26** must continue uninterrupted. Accordingly, **the group of medical experts under the committee duly constituted by NMC** (under the chairmanship of **Dr. Achal Gulati**), have unanimously reached to a conclusion to adopt **interim guidelines** for admissions in AY 2025-26.

5. Functional Assessment of Disabilities

The previously mandated arithmetic **threshold** shall be no longer applicable. Instead, emphasis will be placed on assessing a candidate's **functional ability** to meet the academic and clinical demands of the MBBS course.

6. Mandatory Use of UDID Portal

As per **Gazette Notification S.O. 1736(E) dated 05.05.2021**, issued by the **Department of Empowerment of Persons with Disabilities (DEPwD)**, all disability certificates and UDID cards must be issued via the **UDID online portal**, effective **June 1, 2021**.

Accordingly, the UDID card has been established as a mandatory document for persons with disabilities. In this context, it may be regarded as an essential and authoritative proof for evaluating the eligibility of meritorious NEET UG candidates under the disability category..

7. Evaluation Framework Based on MoSJE Guidelines

Further in view of the paramount importance of patient safety and clinical competence, the assessment of candidates with disabilities may be conducted in accordance with the recently notified guidelines dated 12.03.2024 issued by the Ministry of Social Justice and Empowerment (MoSJE). These guidelines provide a structured and uniform framework to ensure that the evaluation of disability is both comprehensive and consistent with the responsibilities inherent to medical practice.

8. Institutional Responsibilities under the RPwD Act

The medical colleges as per the recommendations prescribed under RPwD Act, 2016, shall make maximum efforts in accommodating and facilitating the candidates with disabilities:

- ***Non-Discrimination in Admission and Education (Section 16):***

Institutions must ensure that no student with a disability is denied admission on the grounds of disability and must provide an inclusive education system at all levels.

- ***Infrastructure Accessibility (Section 45):***

Institutions must ensure barrier-free access to buildings, classrooms, libraries, laboratories, hostels, and other facilities as per the standards notified by the Government of India.

- ***Sensitization and Capacity Building:***

Colleges are encouraged to conduct awareness and sensitization programs for faculty, staff, and students to promote an inclusive environment and reduce attitudinal barriers.

- ***Nodal Officer for Disability Affairs:***

Institutions are advised to appoint a dedicated Nodal Officer or establish a Disability Cell to address the concerns and support needs of students with disabilities.

• **Grievance Redressal Mechanism:**

An accessible and responsive grievance redressal system must be in place to address complaints related to discrimination or lack of accommodation.

9. Decision Taken

The expert panel **unanimously agreed** on the following for MBBS admissions under the PwBD category for AY 2025–26:

- PwBD candidates must submit:
 - A **valid UDID card** issued by a designated medical authority under MoSJE.
 - **Self-Certified affidavits** in the format provided under **Schedule -I**.
 - **The candidate will have to approach the designated medical board for verification of their self-certified affidavit.**
- Designated Medical Boards (16 designated medical boards) are required to undertake following duties:
 - The competencies mentioned in the appendix under Schedule-I are basic & mandatory. The candidates, to the satisfaction of the designated medical board, may demonstrate the competencies that have been declared by him/her. If the board finds the declared competencies unsubstantiated based on the candidate's performance, it must issue a reasoned decision declaring him/her ineligible to pursue medical course.
 - If the candidate while self-declaring the essential competencies mentions one or more competencies in negative or is not able to demonstrate one or more of the listed essential competencies, the board shall see if he/she is able to compensate such deficits, by other alternative functionalities; and may take a holistic view regarding his capability to pursue MBBS course.
 - The designated medical boards may utilize standardized tests and tools to evaluate the abilities of the candidates, as per their declaration, instead of focusing on the disabilities.
 - All decisions of the designated medical board(s) shall be in the form speaking orders.

Admissions will be processed by the **counseling authority**, based on **NEET 2025 scores**, institutional preferences, and verification of required documents by the concerned designated medical board(s). Medical colleges will provide accommodations accordingly.

ORDER

In supersession of the previous orders dated 24-8-2011 and F.7(6)NRI/DME/Acad/2017/3486 dated 19-6-2018 issued earlier by the State regarding filling up seats of NRI quota till date, Following will be the guidelines applicable for the admission in Under Graduate/Post-Graduate, Medical/Dental Courses under NRI quota in all Private and Government Institutions of the State:-

1. A. At least one of the parents of students should be an NRI and shall ordinarily be residing abroad as an NRI; or
 B. The person who sponsors the student for admission should be a first degree relative of the student (i.e. real Brother/real Sister) and should be ordinarily residing abroad as an NRI; or
 C. If student is taken as a ward by some other nearest relative [as mentioned below (i) to (v)], such student may also be considered for admission provided the guardian has bonafidely treated the student as a ward. For this, following nearest relative (NRI) of candidate, who should be ordinarily residing abroad as an NRI can only be considered:-
 - i. Real brother and sister of father i.e. real uncle and real aunt.
 - ii. Real brother and sister of mother i.e. real maternal uncle and maternal aunt.
 - iii. Father and mother of father i.e. grandfather and grandmother.
 - iv. Father and mother of mother i.e. maternal grandfather and maternal grandmother.
 - v. First degree-paternal and maternal cousins.
2. **For PIO / OCI:-** Persons of Indian Origin (PIOs), Overseas Citizen of India (OCIs) are allowed for admission under NRI Quota in UG and PG (Medical /Dental) courses in the State of Rajasthan.
3. All NRI Candidate shall submit a proof of being sponsor as NRI/OCI/PIO in the form of certificate issued by the Indian embassy/Ministry of external affairs, Government of India for this purpose. In the absence of that certificate a duly notarized affidavit executed by the sponsor and notarized by the Notary Public of the foreign country where the sponsor resides being submitted by the sponsor, it be treated as sufficient as to the factum of the residence of the sponsor.
4. An affidavit from the sponsor that he/she looks after such student and will sponsor the entire fee of the candidate.

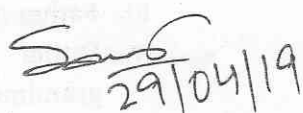
